Explanation of Responses:

1. Includes 101,852 restricted stock units ("RSUs") remaining unvested pursuant to an award of 122,222 RSUs granted under the 2021 Stock Incentive Plan, as amended, of Ocular Therapeutix, Inc. (the "Corporation") on February 22, 2024. Each RSU represents a right to receive one share of the Corporation's common stock. Subject to the reporting person's continued service to the Corporation, the RSUs will vest over three years, in equal quarterly installments, beginning on the date of grant.

2. This option was granted on May 16, 2022 and vests over four years, with 1/48 of the shares underlying the option vesting monthly beginning on June 16, 2022.

3. This option was granted on February 22, 2024 and vests over four years, with 1/4 of the shares underlying the option vesting on February 21, 2025 and 1/48 of the shares vesting monthly thereafter.
